### Rules and Regulations – Farmer's Market

1. Fair Date: September 14, 2024
2. Set up time: 7:30 a.m. to 9:00 a.m. Vehicle must be removed from the fairgrounds by 9:00 a.m. This will be strictly enforced. Hours of operation: 9:00 a.m. to 5:00 p.m.
3. Proof of Liability Insurance is mandatory.
4. The Agassiz Agricultural & Horticultural Association assumes no responsibility for items or belongings in your location.
5. Vendors will be allotted 10x10 sq. ft space on a first-come first-served basis. Vendors must supply their own tables, chairs, canopy, and/or umbrella. No power access.
6. All items sold must be made, grown, produced, or processed locally. Vendors must be actively involved in the production of all products available for sale.
7. Some educational material must be provided to the public about the product(s).
8. Vendors must clearly and visibly display signage indicating the price of each product for sale.
9. Displays are to be visually appealing (no garbage, tarps, etc.).
10. Site location will be issued the morning of the Fair on a first-come first-served basis.
11. The vendor application must be received a minimum of one week prior to the Fair (no later than September 6, 2024). Vendors must have confirmation of space availability prior to the Fair.
