Rules and Regulations – Food Booth

1. Fair Dates: September 17, 2021 (only part of the fair is operational - no animals) and September 18, 2021 (full activities).
2. Food booth hours of operation: Friday - 3:00 p.m. to approximately 9:00 p.m. and Saturday - 9:00 a.m. to approximately 6:00 p.m.
3. The Agassiz Agricultural and Horticultural Association assumes no responsibility for items or belongings in your location.
4. Vendors must clearly and visibly display signage indicating the price of each product for sale.
5. Exhibitor parking will be available to help you with restocking.
6. Vendors need to supply their own tables, chairs and canopy or umbrella.
7. Site location will be issued at the Corn Bank Fair Office or by prior arrangement.
8. The Agassiz Agricultural and Horticultural Association requires all displays/vendors/equipment be visually appealing (i.e. no tarps, garbage).
9. Must have a valid health permit or arrange for a health permit.
10. Any vendors needing power must supply their own cord (heavy duty outside cord).
11. Vendors must have confirmation of space availability prior to the fair.
12. The vendor application must be received a minimum of one week prior to the fair, ie no later than September 10, 2021.
